

Administration and the University.

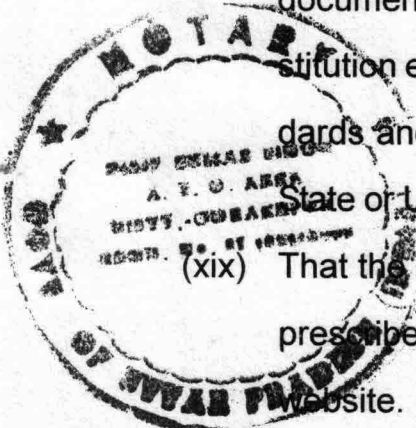
ing satisfactory facilities and for proper programme implementation.


